Policy Statement 2016-2017

REGISTRATION

All students must complete a Registration/Renewal Form prior to beginning lessons stating understanding and compliance with current HMA policy. There is a non-refundable *\$20 Registration Fee*.

TUITION

HMA is making every effort to maintain quality instruction at a reasonable cost. Therefore, *tuition of \$82* will remain the same for the ensuing year. Payment is due on the first of the month. Payments received after the 10th of the month are subject to a *\$10 late fee*.

BILLING

Monthly billing statements will be placed in student mailbox and e-mailed the last week of the month prior to due date. Just like other businesses, it is crucial for HMA to receive payments on time. Please make checks payable to Hamlin Music Academy (HMA).

MISCELLANEOUS FEES

MUSIC AND LESSON MATERIALS

HMA purchases music for the students and partners with parents on the upfront reimbursement. Music and material fees are added to the monthly tuition lesson fee, when applicable.

CONTEST/FESTIVAL/EXAMS

Optional music enhancing opportunities vary by instrument. Fees for these events are the responsibility of the student, payable in advance. Details will be given prior to the event.

CALENDAR

Please refer to HMA Academic Year calendar and wall postings for scheduled breaks, competitions and music opportunities.

STUDENT ABSENCE

Please contact your instructor as far in advance as

possible if you are unable to attend a lesson. A make-up lesson will be arranged only for extenuating circumstances at the discretion of the instructor (death in family, emergency trauma). A make-up lesson not offered for unexcused absences (sports, minor illness, no show, no call).

INSTRUCTOR ABSENCE

If instructor has a conflict in his/her schedule a make-up lesson will be offered.

WEATHER CANCELLATIONS

In the event of school closing HMA will be open for lessons. Most often roads and weather have cleared by lesson time.

LESSON WITHDRAWAL

Please provide a two (2) week notice if you decide to discontinue lessons. HMA appreciates this business courtesy to allow time to restructure lesson schedule. Notification received less than two (2) weeks will require the month's tuition fee.

A BRIEF NOTE ABOUT "TUITION"

Tuition is based on your enrollment, not on lesson attendance. We are providing a service such as a gym, sport or a dance studio provides, which you are charged for, whether you attend or not. Tuition covers time while teaching plus many other hours spent in the following ways:

Lesson preparation, recital preparation, bookkeeping, enrolling students in educational events and attending these events, membership dues in professional teachers organizations, ongoing education (workshops, convention, classes, etc) studio upkeep (providing quality instruments to teach on and maintenance of them); and researching, stocking and preparing materials for student lessons.

As self-employed instructors, we provide our own retirement and insurance needs without paid vacation or sick leave that other professions provide.
